SECTION 2: HAZARDS IDENTIFICATION.

2.1 Classification of the mixture.

The product is not classified as hazardous within the meaning of Directive 1999/45/EC.

2.2 Label elements.

This product is not dangerous.

2.3 Other hazards.

In normal use conditions and in its original form, the product itself does not involve any other risk for health and the environment.

SECTION 3: COMPOSITION/INFORMATION ON INGREDIENTS.

This mixture does not contain any substances presenting a health or environmental hazard within the meaning of the Dangerous Substances Directive 67/548/EEC or Regulation (EC) No. 1272/2008, assigned a Community workplace exposure limit, classified as PBT/vPvB or included in the Candidate List.

Skin contact.

Remove contaminated clothing. Wash skin vigorously with water and soap or a suitable skin cleaner. **NEVER** use solvents or thinners.

SECTION 7: HANDLING AND STORAGE.

7.1 Precautions for safe handling.

The product does not require special handling measures, the following general measures are recommended:

FERTILIZER

Efficient is a nitrogen fertilizer to ensure high efficiency and persistence. Through its two distinct forms of nitrogen: urea to meet the immediate needs of the plant (effect "boot"), and from urea formaldehyde, to ensure a progressive availability of nitrogen, which is gradually made available to the crop.
